

Player Contract

______(player) desires to participate in the USA club Volleyball program administered by The Flatlands Volleyball Club a member of the Ohio Valley Region. ______ (parent) is the parent/guardian of said player and gives permission for player to participate in the activities of Flatlands Volleyball Club.

In exchange for The Flatland's agreement to permit player to participate in The Flatland's Volleyball Club Program:

Parent and Player Agree to:

- 1. Pay all FVBC fees in a timely manner as stated in the payment scheduled supplied at tryouts:
- 2. Become familiar with and adhere to all FVBC guidelines including eligibility, team rules and regulations (pertaining to both parents and players), and follow an athlete appropriate code of conduct.
- 3. Become familiar with and adhere to all OHSAA eligibility guidelines;
- 4. Exhibit a commitment to FVBC through practice and tournament attendance.

Player and parent understand and acknowledge that volleyball is a vigorous and potentially dangerous activity and that participation in practices and matches poses a risk to the player's well- being. Parent and player, nonetheless, desire player's participation and release and hold harmless FVBC and its officers and coaches from liability in the event of injury to said player.

Player and parent understand that failure to pay FVBC fees in the time designated by FVBC may result in the player being suspended from full participation in the team or may result in suspension or dismissal from the FVBC without refund of partially paid fees. Player and Parent acknowledge the FVBC officers and/or coaches are the final arbiters of whether Player and Parent have complied with FVBC and /or team rules and regulations.

Player and Parent understand and agree that a partial or full refund or return of fees or other monies paid by player and parent to FVBC will only be given in the event of Player injury and in those circumstances will be based on the format established for prorated refunds. Refunds or return fees will not be given for any other reason. This includes but is not limited to:

1. Player's suspension or dismissal from the FVBC program;

2. Player's decision to discontinue their participation in the FVBC program;

Player and Parent understand and agree that there is no guarantee in the amount of playing time player receives in exchange for fees and other monies paid by Player and Parent. This is a competitive training environment and playing time is earned not distributed equally.

Player and Parents must remain in good standing with the FVBC for the duration of the season. Players may be removed from teams for breaking any rule in the FVBC guidelines including *unsportsmanlike conduct by player or parents*. Players that are dismissed from FVBC for any reason are not entitled to any portion of their fees back.
